

Terms and Conditions

Videography & Photography Services

1. Services Offered

Services include videography, photography, or a combination of both, as agreed upon prior to booking.

2. Videography Pricing

- **Short-Form Content / Reels**
Standard rate: £65
Applies to short-form video content intended for social media use.
- **Long-Form Content & Extended Video Projects**
Projects involving long-form content, more than 30 video clips, or videos exceeding 1-3 minutes are priced between £85 and £125, depending on scope and complexity.

Final pricing will be confirmed before the booking is secured.

3. Photography-Only Pricing

- **Half-Day Photography Shoot**
Duration: 2 hours
Rate: £65
- **Full-Day Photography Shoot**
Duration: Up to 6 hours
Rate: £125

The number of final images will be agreed upon in advance.

4. Combined Videography & Photography Packages

- **Half-Day Combined Package**
Duration: Up to 4 hours
Rate: £85
- **Full-Day Combined Package**
Duration: Up to 8 hours
Rate: £165

5. Extended Time & Custom Quotes

Any additional time, revisions, or services outside the agreed package will require a **custom quotation** and written approval before proceeding.

6. Deposits & Payment Terms

- **A 50% non-refundable deposit is required to secure all bookings.**
- **The deposit is calculated based on the final agreed price.**
- **The remaining balance must be paid before or on the day of the shoot, unless otherwise agreed in writing.**

No booking is confirmed until the deposit is received.

7. Cancellations

- **Cancellations made within 24 hours of the scheduled shoot will result in the loss of the deposit.**
- **Cancellations made more than 24 hours in advance may be rescheduled, subject to availability.**

8. Travel Fees

Travel fees apply when services require travel to the client's location. Costs are calculated based on distance and will be agreed upon before booking confirmation.

9. Usage Rights & Content Ownership

- **The service provider retains full copyright ownership of all photo and video content produced.**
- **The client is granted a non-exclusive licence to use the delivered content for personal or business promotional purposes, including social media and websites.**
- **Content may not be sold, transferred, sublicensed, or used for third-party commercial purposes without written permission.**
- **The service provider reserves the right to use the content for portfolio, marketing, and promotional purposes, unless otherwise agreed in writing.**

10. Delivery Timelines

- **Photography content will be delivered within 7–14 business days after the shoot.**
- **Video content will be delivered within 10–21 business days, depending on project scope.**
- **Delivery timelines may be extended due to revisions, unforeseen circumstances, or delays caused by the client.**

11. Revisions

- **One reasonable round of revisions is included unless otherwise stated.**
- **Additional revisions may incur extra charges, to be agreed upon before work continues.**

12. Late Payments

- **Any outstanding balance not paid within 7 days of the agreed payment date may incur a late fee of 10% of the remaining balance.**
- **Content will not be released until full payment has been received.**
- **Continued non-payment may result in legal action to recover outstanding fees.**

13. Agreement

By paying the deposit, the client confirms they have read, understood, and agreed to these Terms and Conditions.
